- 1. That at the commencement of every term the Pupil will give to the Principal, Headmaster or Headmistress a certificate signed by the Guardian that the Pupil has not suffered from any infectious complaint, that the Pupil has not been staying in a house where such disorder exists, and that the Pupil has not, so far as known, been in contact with any person who has recently so suffered.
- In some cases the Medical Certificate of a private practitioner must be endorsed by the School Medical Officer before admission is

allowed.

- 2. That if the Pupil has suffered from any infectious disease, either during the term or in the holidays, or has lived in a house with anyone suffering from an infectious disease, the Pupil will not return to School without a Medical Certificate, a printed form of which may be obtained from the School or from the Office of the Education Department.
- That the Pupil will not be absent from School without leave of the Principal, Headmaster or Headmistress, except in cases of illness or emergency.
- 4. That the Guardian will notify to the Principal, Headmaster or Headmistress any change of address of the Guardian or of the Pupil.

- 5. That the Pupil will wear the School uniform, if prescribed.
- 6. That the Pupil will not keep any money at the School, except on the Pupil's person.
- 7. That all private property of the Pupil will be clearly marked with the Pupil's name.
- 8. That in the event of the Pupil failing to obtain a satisfactory report from the School, the Guardian will, on request of the Education Committee, withdraw the Pupil from the School and consent to the Pupil's re-direction to another School at the discretion of the Education Committee.
- That the Guardian and the Pupil will, so far as the same are applicable to each, observe the Rules and Regulations of the School.
- 10. That the Guardian will not withdraw nor take steps with a view to withdrawing the complete the school Pupil from the School before the end of the term in which the Pupil shall axis axis at the age xof xxx......
